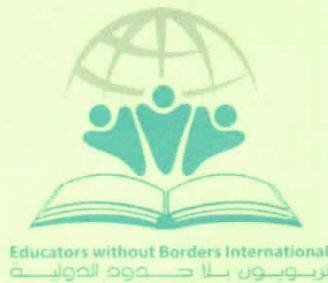

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement is made on education, research and community development

BETWEEN

FACULTY OF MEDICINE AND HEALTH SCIENCES UNIVERSITAS ISLAM NEGERI (UIN) ALAUDDIN MAKASSAR of Indonesia, established in 2005, an educational institution duly organize medical sciences department, medical doctor profession, nursing department, nurse profession, pharmacy department, midwifery department, and public health department, located at Jl. H. M. Yasin Limpo No. 36 Romangpolong Gowa, South Sulawesi, Indonesia.

AND

EDUCATOR WITHOUT BORDER INTERNATIONAL an International organization, concerned with educating children in affected regions, and improving educational and training services in crisis areas located at Geneva, Switzerland

("EWBI")

RECITALS:

EDUCATOR WITHOUT BORDER INTERNATIONAL is located in Geneva, Switzerland

- A. **FACULTY OF MEDICINE AND HEALTH SCIENCES UIN ALAUDDIN MAKASSAR** is located in Romangpolong Gowa, South Sulawesi, Indonesia.
- B. This Memorandum of Agreement provides for the establishment of a general framework to co-operate in the areas of Tri Dharma of Higher Education : collaboration in education, teaching and academic activities, collaboration in research and development, and collaboration in community services between **EDUCATOR WITHOUT BORDER INTERNATIONAL** and **FACULTY OF MEDICINE AND HEALTH SCIENCES UIN ALAUDDIN MAKASSAR**.
- C. The parties agree that this cooperation will be advantageous for both parties on the principles of equality and mutual benefit.

NOW it is understood by the parties as follows:

It is anticipated by the parties that any formal agreement will include reference to (but not be limited to) the following issues:

1. Responsibilities of **EDUCATOR WITHOUT BORDER INTERNATIONAL** :
 - a. Provide Faculty of Medicine and Health Science UIN Alauddin Makassar with the necessary information and other documentation Educator Without Border International's programs.
 - b. Examine options including Faculty of Medicine and Health Sciences UIN Alauddin Makassar/ Educator Without Border International for collaboration in education, academic activities, teaching learning purposes and clinical placement experiences, and articulation arrangements for Faculty of Medicine and Health Sciences UIN Alauddin Makassar.

- c. Facilitate learning linkages in research and development projects between Educator Without Border International and Faculty of Medicine and Health Sciences, UIN Alauddin Makassar.
 - d. Facilitate and collaborate community services project Educator Without Border International and Faculty of Medicine and Health Sciences, UIN Alauddin Makassar.
 - e. Examine options relating to short field courses, exchange program, and professional development for student/staff/lecturers of Faculty of Medicine and Health Sciences UIN Alauddin Makassar in Educator Without Border International.
 - f. Visit and host Faculty of Medicine and Health Sciences, UIN Alauddin Makassar visiting delegations to discuss the terms and conditions that would form long-term, specific agreements between the two parties.
2. Responsibilities of FACULTY OF MEDICINE AND HEALTH SCIENCE UIN ALAUDDIN MAKASSAR
- a. Provide Educator Without Border International with the necessary information and other documentation of Faculty of Medicine and Health Science UIN Alauddin Makassar's programs.
 - b. Examine options including Faculty of Medicine and Health Science UIN Alauddin Makassar/ Educator Without Border International for collaboration in education, academic activities, teaching learning purposes and clinical placement experiences, and articulation arrangements for Educator Without Border International.
 - c. Facilitate learning linkages in research and development projects between Faculty of Medicine and Health Science UIN Alauddin Makassar and Educator Without Border International
 - d. Facilitate and collaborate community services project between Faculty of Medicine and Health Sciences, UIN Alauddin Makassar and Educator Without Border International Examine options relating relating to short field courses, exchange program, and professional development for students/staffs/lecturers of Educator Without Border International in Faculty of Medicine and Health Science UIN Alauddin Makassar.
 - g. Visit Educator Without Border International and host School of Nursing and Midwifery, La Trobe University visiting delegations to discuss the terms and conditions that would form long term, specific agreements between the two parties.
3. Financial Arrangements
- The two parties agree that they have separate financing responsibilities for this preliminary stage of cooperation and discussion. Neither party may call upon the other party for advance funding to meet advance expenditure obligations.
4. Intellectual property
- a. In this clause, intellectual property includes all copyright, all right concerning inventions (including patents), plant varieties, trademark (including service marks), designs, circuit layouts, all other rights resulting from intellectual activity in the

industrial, scientific, literary, or artistic fields and any right to have confidential information kept confidential.

- b. Ownership of intellectual property that exists before this memorandum of agreement will not be transferred under this memorandum of agreement.
- c. The title to and ownership of intellectual property generated according to this memorandum of agreement will vest in the party that creates it.
- d. In the case of intellectual property created jointly by the parties, the parties will negotiate in good faith agree on the use of the intellectual property on the principle that such intellectual property would be jointly owned by the parties in proportion to their respective contribution (financial and in-kind) to the creation of that intellectual property.

5. Confidentiality and disclosure

- a. The recipient, its employees, staff, researchers, and students, shall treat all information and material supplied by Educator Without Border International and Faculty of Medicine and Health Science UIN Alauddin Makassar following or under the memorandum of agreement as confidential.
- b. The two parties, their employee, contractors, or agents shall not disclose or make public any information or material acquired or produced in connection with or by the performance of this memorandum of agreement without the prior written consent of the other party.

6. Names, trademarks, and logos

Neither party will use the name or any identifying mark or logo of the other party in any material, advertisement, publication, or other media without first obtaining written permission from the other party, such permission not to be unreasonably withheld.

7. Term

This Memorandum of Agreement shall operate for five (5) years commencing on the date of signature by both parties. This Memorandum of Agreement may be renewed with the agreement of the parties. The terms and conditions for any such renewal shall be agreed in writing and signed by the two parties.

8. Revision

Both parties shall send written notice and consult each other at least 6 months before the revision of the Memorandum of Agreement.

9. Termination

This Memorandum of Agreement shall cease provided one of the parties gives written notice to the other of its intention to terminate at least 6 months before termination. In the event of termination under this clause, neither party can claim from the other in respect of expenditure or obligations incurred up to the date of termination.

10. No-binding

Other than in regards to clauses 4 and 5, this Memorandum of Agreement is a statement of intent and is not intended to create legal obligations between the parties.

11. Relationships of the parties

- a. No part of this Memorandum of Agreement has the authority to bind any other party by contract or otherwise.
- b. Nothing in this Memorandum of Agreement will be interpreted as creating the relationship of principal and agent or a trust, partnership, joint venture, or any other form of a fiduciary relationship between the parties.
